

President's Report October/November 2017

Partnerships

- Crystal City ISD – met with superintendent regarding the potential of an Early College High School or Academy model for the district. The ISD will research further into the details and try to see if it will be feasible for next fall.
- Medina Valley ISD – met with superintendent to renegotiate our lease for the Castroville facility and discussed the possibility for an Early College High School for their district. We have a revised lease for Board consideration in November
- Met with both Dilley and Knippa administration regarding the Early College High School. Discussed opportunities for improvements, the need to develop an evaluation document, current trends and projected future of the programs
- Attended the dedication of the Del Rio Early College High School campus on October 30. Del Rio Board and Administration very complimentary of the partnership with SWTJC
- Traveled to Eagle Pass on October 20 to meet with Texas Workforce Commissioner, Julien Alvarez. Discussed our partnership with South Texas College, Laredo Community College and Fort Duncan Hospital (Skills Development Grant). The commissioner praised our visionary approach in using our partnership to deliver training to our health care providers. He also encouraged us to continue expanding our engagement of K-12 partnership and emphasized the fields of cyber security, coding, and drone pilots.
- Will travel to Laredo Community College on Friday November 10th to sign an MOU between South Texas College, Laredo Community College, Del Mar College, Texas A&M International and SWTJC to implement and sustain educational initiatives focused on increasing individual success and post-secondary completion and provide the tools needed to be successful in their individual career and educational endeavors.

Enrollment

Cabinet and key stakeholders met with individuals from Civitas to demo a college course scheduler software. The software assists students in preparing course schedules. We understand that we have to keep improving our services to students, yet we have very limited resources. A foundation is providing grant funds that will cover the first year cost, half of the second year cost; our initial investment is \$5,000 for installation. At year 3, the cost is \$20,000 (1/3 of the cost to hire one additional advisor)
