CARL D. PERKINS GRANT – Student Acknowledgement

The Carl D. Perkins Grant is a federal grant that was created to assist Career and Technical Education students. The grant must be administered in accordance with federal legislation.

Qualifications:

- a) You must be currently enrolled in a career and technical education program and the respective program courses.
- b) You must be enrolled at a minimum as a part-time student with 6 semester hours Fall & Spring and/or 3 hours in Summer I & II.
- c) You must have a current 2.0 Grade Point Average or better.
- d) You must meet one of the Special Populations Categories.

Daycare Assistance:

- a) **The Grant will ONLY pay portion of the amount for daycare. Student will be responsible for the remaining portion.**
- b) Children's absences from the day care center are the choice and the financial responsibility of the parent.
- c) When absent from class, childcare will not be paid for by the Grant.
- d) The Grant will not pay for childcare on holidays (e.g., Spring Break, Easter, etc.)
- e) Childcare services must be obtained from a licensed day care center or a registered home.
- f) The childcare facility is the choice of the parent.
- g) Childcare payment is made directly to the facility each month.

Textbook Assistance:

- a) Any Carl D. Perkins textbooks you receive must be returned to the Carl D. Perkins Office as soon as the semester ends.
- b) Students who **do not return/replace books/materials** will have a business hold on their grades.
- c) **Students who are graduating must return all textbooks/materials received from the Carl D. Perkins Office prior to graduation in order to receive a diploma.**

Transportation:

- a) Van services will be chosen if available and class schedule permits.
- b) Gas vouchers provided only if there are no van services available.
- c) Gas vouchers are provided only to students traveling to attend classes/training and the distance is 10 miles or more from current living quarters to campus/training facility.
- d) Gas vouchers are for purchase of fuel only, any purchases of items with voucher other than for fuel will result in termination from further assistance from Carl D. Perkins Grant.
- e) Students living in the same area must carpool when available.
- f) Receipts **MUST** be turned in weekly in order to receive voucher for following week.

Photocopies of the following documents must be submitted with application as applicable:

- Degree Plan
- Financial Aid Award Letter
- Registration Receipt
- Public Assistance Award Letter (WIC, Food Stamps, Medicaid, TANF, SSI)

If applying for daycare assistance, include the following also:

- Birth Certificate(s) (child)
- Daycare/Registered Home License

To be eligible for support services provided through the Carl D. Perkins Career and Technical Education Grant, I understand that I must be pursuing a career and technical education degree/training program and that I must take only the required courses listed in my degree plan except for remedial courses. I also understand that I am expected to maintain at least a 2.0 grade point average and be enrolled in a minimum of 6 semester hours (during Fall and Spring) or 3 semester hours (during a summer session) to remain eligible. I agree to return textbooks/materials provided by the Carl D. Perkins Grant at the end of the semester or immediately if I am unable to complete the semester. A "HOLD" will be placed on my records in the Business Office and in the Registrar's Office if I do not uphold compliance with the above statement.

I have read and understand the eligibility requirements and agree to any and all conditions upon acceptance of the Carl D. Perkins Vocational and Applied Technology Education Act support services.
